The Minister of Public Health, Doctor Malachie MANAOUDA, with reference to the notification issued by PIERRE FABRE MEDICAMENT Laboratory, attracts the attention of the public to the presence of counterfeit Cyteal foaming solution, 250ml bottle, available in Cameroon.

This notification of counterfeiting follows a quick check of batches G00729 and 3G05E, which showed that the bottles are not new, the units are packaged in plastic in sets of three rather than the usual single units, the smell of the solution does not correspond to the characteristic Cyteal smell and is closer to a household detergent smell, the counterfeit Cyteal solution is more viscous than the compliant Cyteal foaming solution.

In fact, the compliant Cyteal is a pale yellow viscous solution that foams when shaken. It is used for cleansing infected skin and mucous membrane lesions that are infected or at risk of infection.

The Minister of Public Health calls for increased vigilance from everyone, particularly users of this antiseptic, to insist on checking the organoleptic properties (visual appearance, texture, smell) of all batches of the product concerned, and recommends that the following measures be observed:

- make sure before use that Cyteal shows no signs of counterfeiting as mentioned above;
- report any adverse events that may arise to the following address alertevigilancedpmlcameroon@gmail.com;

• return the said products to your suppliers, if any change in the organoleptic properties of the product is observed.
